- Advises and represents limited companies and company directors in public inquiries before the Traffic Commissioner in respect of breaches of the Goods Vehicles (Licensing of Operators) Act 1995.

## Notable Police Discipline cases

---

PC G & T

Represented PC G and T in relation to gross misconduct allegations of duties and responsibilities, authority, respect and courtesy, and discreditable conduct. Officers alleged to have failed to obtain information about a detainee's health and medication and then ridiculed him as he lay unconscious in a cell. The detainee later died in custody.

---

PC B

Represented PC B in relation to gross misconduct allegations of honesty and integrity, confidentiality, duties and responsibilities and discreditable conduct. Officer alleged to have tricked a colleague into obtaining information about an ongoing criminal investigation.

Represented PC S in relation to gross misconduct allegations of honesty and integrity, duties and responsibilities and discreditable conduct. Officer alleged to have used his position to form sexual relationships with two women, one of whom lied in a witness statement upon his instruction.

## Coronial & Public Law
