- *Regina v RK - Manchester Crown Court (2020)*
Represented the first defendant in a two-handed drugs turf murder. Case ongoing.
- *Regina v CD - Central Criminal Court (2019)*
Nine-handed knife-killing.
- *Regina v SL - Birmingham Crown Court (2019)*
Three-handed murder involving multiple weapons.
- *R v WM - Preston Crown Court (2019)*
Defendant charged with multiple counts of rape and other serious sexual offences against women and children.
- *Regina v W & W - Reading Crown Court (2018)*
Two-handed murder involving the infliction of over forty stab wounds.
- *Regina v PM - Harrow Crown Court (2018)*
PM was charged, along with his wife, with the systematic rape of, and cruelty to, his own children.
- *Regina v D & Others - Wood Green Crown Court (2018)*
A conspiracy to house, store and transfer lethal firearms for use when required by a notorious North London gang.
- *Regina v DD - Woolwich Crown Court (2018)*
A cross-jurisdictional conspiracy to import heroin, cocaine and firearms through Europe into the UK.
- *Regina v CS - Reading Crown Court (2017)*
Double attempted murder of two schoolgirls.
- *Regina v DS - Portsmouth Crown Court (2017)*
The defendant groomed and raped three small children from the same family having moved into their home.
- *Regina v B & Others - Bristol Crown Court (2017)*
Murder, Attempted Murder and Perverting the course of Justice, arising out of a dispute between two families.
- *Regina v DJ & Others - Stafford Crown Court (2017)*
DJ one of eight charged with targeting and rape of vulnerable school girls.
- *Regina v N & Others - Harrow Crown Court (2017)*
Conspiracy to possess and transfer firearms with intent to endanger life. A planned, sophisticated conspiracy to move firearms across London.

- *Regina v JM - Wolverhampton Crown Court (2016)*
Murder of a pensioner on Christmas Eve outside his home.
- *Regina v CY - Reading Crown Court (2016)*
Grievous Bodily Harm with Intent, committed on a twelve-week old baby.
- *Regina v SH & Others - Reading Crown Court (2016)*
Sixteen year old girl charged as part of a gang, with rape of a twelve-year old girl.
- *Regina v BB - Nottingham Crown Court (2016)*
Grave sexual offending against five women from the same family, including extremely vulnerable mother and daughter.

Financial & Corporate Crime

Since being called to the Bar, Rossano has been prosecuted and defended in heavyweight financial and business crime, bribery, corruption and large-scale frauds of all descriptions.

This has included pre-charge advice and matters of substantial litigation.
